Mayor's Message

I hope this message finds you all well.

We are now in the process of summing up the past year (2023) and preparing the budget for 2024. The project list is shrinking as we have had major capital projects over the past 5 years. Councilors will analyze the projects and determine the key areas that money should be allocated to. There will be a public comment period before the 2024 budget is adopted.

Last year's road work will be finished as soon as the cold weather is behind us. There is some work on Oceanview and Sunset. The work consists mainly of fixing driveways and sculping and landscaping. The contractor will be in contact with property owners.

The rehabilitation of the Fire Hall is almost complete. The work has consisted mainly of replacing the siding and the installation of a shower on the top floor. It is very important to maintain our physical assets in good condition to avoid costly repairs in future years.

We have good news from the Provincial Government. They have established a fund for northwestern BC to assist communities with money for capital projects. The fund is called the Regional Benefits Alliance (RBA) and allocates \$250 million to this region over the next 5 years. Over the next few months a committee will be working on a formula on how to divey up the money. I will let you all know when we have received notification. This is a major milestone in our ability to provide ongoing services to residents. The negotiations with Province was over 10 years in the making. A major win for our area.

Have a great March, Spring begins at the end of this month.

Highlights from February Council Meetings

Representatives from CN gave Council a presentation (via Zoom) regarding an update on CN and an overview of CNs Emergency Plan regarding rail cars.

Council made a motion to support the following:

- Skeena Taxi Ltd.- provided a letter of support for an additional wheel chair accessible taxi for our area.
- ♦ Prince Rupert Special Events Society- "31st Children's Festival" provided a contribution of \$500 towards this event.
- ♦ BC Hydro- North Coast BC Electrification- provided a letter of support.
- ♦ Grant Applications- Alwyn Lake & Wolf Creek Dams two applications were supported one for the Operating, Maintenance and Surveillance Plan and a Dam Emergency Plan. A contribution of \$10K was also approved for each application.
- Waterfront Park- approve the application to Crown Land to secure the land for the proposed park.
- Grant Application- provided support for the grant application to Northern Development Trust Initiative - Community Places for the Port Edward Boat Launch.
- Building Inspection Agreement with City of Prince Rupert- approved the agreement for services to have the City of Prince Rupert conduct building inspections for Port Edward.
- Fire Hall will be getting new bathrooms for the volunteer firefighters.
- Urban Systems has been contracted to provide the District with a Climate Action Plan.
- Urban Systems have been contracted to update the Official Community Plan and Zoning bylaw.
- White House- staff to explore options to develop this property.
- ♦ Charles Hays Secondary School- approved a full page ad for \$250.
- ♦ Nisga'a North JANT- approved a contribution of \$500 towards this event.
- Waterline Right of Way- approved the registered a right of Way for a waterline.
- ⋄ The 2023 Financial Report Update was provided by staff and approved.
- ♦ The 2024 Budget Schedule timeline was accepted and a workshop date needs to be determined.
- Staff follow ups- Digital signs along Skeena Drive not working, CN Rail cars near the old Kwinitsa Station, Look into cost of "slow-down" signs.
- ♦ Resource Benefits Alliance funding announcement of \$250 million over five years-send a thank you letter to the Province.

Port Edward School - Kindergarten Registration

If your child is 5 years old by December 31, 2024, s/he is eligible to start school this coming September.

When registering for a Kindergarten program, please bring:

- Your child's Birth Certificate (or other proof of age such as a Provincial ID Card, Permanent Residence Card or Passport);
- B.C. Care Card;
- Immunization Records;
- Proof of address

Registration will take place at the Port Edward School from 9:00 to Noon, Tuesday(s) and Thursday(s) ONLY.

Parents may choose to defer their child's entry to school, based on readiness, for one year. Please contact your neighborhood school for consultation if you are concerned about your child's readiness.
